AN ACT

AMENDING TITLE 9, CHAPTER 4, ARTICLE 8, ARIZONA REVISED STATUTES, BY ADDING SECTION 9-500.54; AMENDING TITLE 11, CHAPTER 2, ARTICLE 4, ARIZONA REVISED STATUTES, BY ADDING SECTION 11-269.31; AMENDING TITLE 41, CHAPTER 4, ARTICLE 7, ARIZONA REVISED STATUTES, BY ADDING SECTION 41-807; RELATING TO IMMIGRATION ENFORCEMENT.

1 Be it enacted by the Legislature of the State of Arizona:

2 Section 1. Title 9, chapter 4, article 8, Arizona Revised Statutes,
3 is amended by adding section 9-500.54, to read:

5 enforcement; prohibition; definition

6 A. NOTWITHSTANDING ANY OTHER LAW, PROPERTY THAT IS OWNED BY A CITY
7 OR TOWN IN THIS STATE MAY NOT BE USED, OCCUPIED, LEASED, LOANED OR
8 OTHERWISE MADE AVAILABLE, TEMPORARILY OR PERMANENTLY, FOR ANY CIVIL
9 IMMIGRATION ENFORCEMENT ACTIVITY OR OPERATION UNLESS THE CIVIL IMMIGRATION
10 ENFORCEMENT ACTIVITY OR OPERATION IS CONDUCTED PURSUANT TO A VALID
11 JUDICIAL WARRANT SPECIFYING THAT THE ACTIVITY OR OPERATION MAY BE
12 CONDUCTED AT A PARTICULAR PROPERTY.

20 FOR CIVIL IMMIGRATION ENFORCEMENT ACTIVITIES OR OPERATIONS BY IMMIGRATION
21 ENFORCEMENT OFFICERS WITHOUT A VALID JUDICIAL WARRANT.

22 D. A PERSON WHO IS ON ANY PROPERTY THAT IS OWNED BY A CITY OR TOWN
23 IN THIS STATE MAY NOT BE QUESTIONED, DETAINED OR ARRESTED BY AN
24 IMMIGRATION ENFORCEMENT OFFICER UNLESS THE IMMIGRATION ENFORCEMENT OFFICER
25 PRESENTS A VALID JUDICIAL WARRANT THAT IS APPLICABLE TO THE PERSON.

30 Sec. 2. Title 11, chapter 2, article 4, Arizona Revised Statutes,
31 is amended by adding section 11-269.31, to read:

34 A. NOTWITHSTANDING ANY OTHER LAW, PROPERTY THAT IS OWNED BY A
35 COUNTY IN THIS STATE MAY NOT BE USED, OCCUPIED, LEASED, LOANED OR
36 OTHERWISE MADE AVAILABLE, TEMPORARILY OR PERMANENTLY, FOR ANY CIVIL
37 IMMIGRATION ENFORCEMENT ACTIVITY OR OPERATION UNLESS THE CIVIL IMMIGRATION
38 ENFORCEMENT ACTIVITY OR OPERATION IS CONDUCTED PURSUANT TO A VALID
39 JUDICIAL WARRANT SPECIFYING THAT THE ACTIVITY OR OPERATION MAY BE
40 CONDUCTED AT A PARTICULAR PROPERTY.

41 B. A PARKING LOT, PARKING GARAGE OR VACANT LOT THAT IS OWNED BY A
42 COUNTY IN THIS STATE MAY NOT BE USED AS A STAGING AREA, PROCESSING
43 LOCATION OR OPERATIONS BASE FOR CIVIL IMMIGRATION ENFORCEMENT.

44 C. WITHIN THIRTY DAYS AFTER THE EFFECTIVE DATE OF THIS SECTION, THE

3 IMMIGRATION ENFORCEMENT ACTIVITIES OR OPERATIONS BY IMMIGRATION
4 ENFORCEMENT OFFICERS WITHOUT A VALID JUDICIAL WARRANT.

17 A. NOTWITHSTANDING ANY OTHER LAW, PROPERTY THAT IS OWNED BY THIS
18 STATE MAY NOT BE USED, OCCUPIED, LEASED, LOANED OR OTHERWISE MADE
19 AVAILABLE, TEMPORARILY OR PERMANENTLY, FOR ANY CIVIL IMMIGRATION
20 ENFORCEMENT ACTIVITY OR OPERATION UNLESS THE CIVIL IMMIGRATION ENFORCEMENT
21 ACTIVITY OR OPERATION IS CONDUCTED PURSUANT TO A VALID JUDICIAL WARRANT
22 SPECIFYING THAT THE ACTIVITY OR OPERATION MAY BE CONDUCTED AT A PARTICULAR
23 PROPERTY.

24 B. A PARKING LOT, PARKING GARAGE OR VACANT LOT THAT IS OWNED BY
