### A CONCURRENT RESOLUTION

PROPOSING AN AMENDMENT TO THE CONSTITUTION OF ARIZONA; AMENDING ARTICLE VII, CONSTITUTION OF ARIZONA, BY ADDING SECTION 19; RELATING TO ELECTION REQUIREMENTS.

1 Be it resolved by the Senate of the State of Arizona, the House of  
2 Representatives concurring:

3 1. Article VII, Constitution of Arizona, is proposed to be amended  
4 by adding section 19 as follows if approved by the voters and on  
5 proclamation of the Governor:

6 19. Elections; citizens; foreign contributions;  
7 identification; early voting; severability

8 SECTION 19. A. ONLY CITIZENS OF THE UNITED STATES  
9 SHALL BE ELIGIBLE TO REGISTER AND VOTE ONCE FOR EACH AVAILABLE  
10 OFFICE OR BALLOT MEASURE, IN ANY PUBLIC ELECTION IN ARIZONA.

11 B. CONTRIBUTIONS FROM ANY FOREIGN PERSON OR FOREIGN  
12 CORPORATION TO ANY ARIZONA CANDIDATE OR BALLOT MEASURE  
13 CAMPAIGN SHALL BE PROHIBITED.

14 C. CONCURRENT WITH CASTING A BALLOT, ALL ELECTORS SHALL  
15 BE REQUIRED TO PROVIDE A GOVERNMENT ISSUED IDENTIFICATION.  
16 ACCEPTABLE IDENTIFICATION, AS PROVIDED BY LAW, SHALL BE MADE  
17 AVAILABLE TO ELECTORS FREE OF CHARGE.

18 D. TO HELP ENSURE TIMELY ELECTION RESULTS:

19 1. EARLY VOTING, IF AUTHORIZED BY LAW, SHALL END NO  
20 LATER THAN 7:00 P.M. ON THE FRIDAY PRIOR TO THE TUESDAY  
21 GENERAL ELECTION.

22 2. VOTES SHALL NOT BE CAST OR ACCEPTED AFTER POLL  
23 CLOSING TIMES ON GENERAL ELECTION DAY, AS DESIGNATED BY LAW.

24 E. ALL QUALIFIED ELECTORS SHALL HAVE THE RIGHT TO VOTE  
25 IN-PERSON ON ELECTION DAY AT CONVENIENTLY LOCATED POLLING  
26 PLACES.

27 F. ALL QUALIFIED ELECTORS WHO HAVE PROVIDED DOCUMENTED  
28 PROOF OF CITIZENSHIP SHALL BE OFFERED AN OPPORTUNITY TO  
29 RECEIVE A MAIL-IN BALLOT, WHICH SHALL BE PROVIDED SOLELY UPON  
30 THEIR AFFIRMATIVE REQUEST CONFIRMING A SPECIFIC MAIL ADDRESS  
31 PRIOR TO EACH BIENNIAL GENERAL ELECTION, IF MAIL-IN VOTING IS  
32 AUTHORIZED BY LAW, AND IN SUCH A MANNER AS THE LAW PRESCRIBES.

33 G. IF A PROVISION OF THIS ACT OR ITS APPLICATION TO ANY  
34 PERSON OR CIRCUMSTANCE IS HELD INVALID, THE INVALIDITY DOES  
35 NOT AFFECT OTHER PROVISIONS OR APPLICATIONS OF THE ACT THAT  
36 CAN BE GIVEN EFFECT WITHOUT THE INVALID PROVISION OR  
37 APPLICATION, AND TO THIS END THE PROVISIONS OF THIS ACT ARE  
38 SEVERABLE.

39 H. THIS AMENDMENT SHALL COMMONLY BE KNOWN AS "THE  
40 ARIZONA SECURE ELECTIONS ACT."

41 2. The Secretary of State shall submit this proposition to the  
42 voters at the next general election as provided by article XXI,  
43 Constitution of Arizona.
